**ROLL CALL** was taken by Jean Greco, Secretary/Treasurer. Members present were: Mark Sackin, Gary Pezzuolo, and Vito Yeropoli. Also, on the call were Solicitor Lou Perrotta, Engineer Greg DeIPrincepe, and Police Chief Robert Sipe.

Newly appointed Chairman Yeropoli asked for any guest speakers. Resident Susan Buchanan questioned trees and culvert on the bend near her home.
