### **MINUTES OF THE REGULAR MONTHLY MEETING ON JANUARY 2, 2024**

The Mahoning Township Supervisors held their annual reorganizational meeting on Monday, January 2, 2024 at approximately 9:15 a.m. in the meeting room of the Mahoning Township building located at 4538 West State Street, Edinburg, PA 16116.

**ROLL CALL** was taken by Jean Greco, Secretary/Treasurer. Members present were: Mark Sackin, Gary Pezzuolo, and Vito Yeropoli. Also, on the call were Engineer Gregg DelPrincipe and a representative from Solicitor Louis Perrotta's office, Kyle McCree.

Newly appointed Chairman Pezzuolo asked for any guest speakers. Attorney McCree swore into office Gary Pezzuolo and Pezzuolo was thanked for his 20+ years of serving the community.

Sackin made a motion to **ADOPT THE MINUTES** of the December 12, 2023 final budget meeting minutes and the motion was seconded by Pezzuolo with a vote of all in favor. Yeropoli made a motion to adopt the minutes of the regular meeting minutes for December 12, 2023 which was seconded by Sackin with a vote of all in favor.

Sackin made a motion to **PAY THE BILLS** as prepared by Greco since the last month's meeting. The motion was seconded by Pezzuolo with a vote of all in favor.

Pezzuolo made a motion to **PAY THE PAYROLLS** as prepared by Greco since the last month's meeting. The motion was seconded by Yeropoli with a vote of all in favor.

There were **NO TOWNSHIP REPORTS** for any of the following: **ZONING, PLANNING, FIRE DEPARTMENT, POLICE DEPARTMENT**

Pezzuolo asked Greco for any **CORRESPONDENCES** in which Greco shared a letter from Lawrence County stating it does **NOT** own the **BRIDGE ON SANKEY RUN**; and Gregg DelPrincipe noted an approval of a **GRANT FOR SEWER \$417K** that must be spend on equipment upgrades and repairs for items such as screens and ditch rotors.

Pezzuolo noted under **UNFINISHED BUSINESS** that approximately \$40K in funds is designated for equipment and approximately \$35K should be received in 2024.

Pezzuolo noted under **NEW BUSINESS** gratitude and recognition of the **JOHNSON CLUB** for donating \$7K to the police department and \$1K to the fire department.

Pezzuolo then noted the **ANNUAL AUDITORS' MEETING** would be held Wednesday, January 3rd at 3:00 p.m. The Auditor's meeting to set the compensation of the supervisors who are employed full time by the Township. However, in review of the **AUDITORS A VACANCY** exists as in 2023; therefore, Yeropoli made a **MOTION to APPOINT FRANCES "PONCHO" EXPOSITO** which was seconded by Pezzuolo and a vote of all in favor.

Pezzuolo noted the **NEXT REGULAR MEETING** will be back to the 2<sup>nd</sup> Tuesday of the month at 6:00 p.m. for the calendar year 2024 starting with February 13, 2024.

Pezzuolo asked if anything further needed to be address by those in attendance in which resident Marcy Romano asked about the grant that was noted in the paper for the sewer was the same as the one mentioned; and it is the same.

Yeropoli made a motion to **ADJOURN** which was seconded by Pezzuolo with a vote of all in favor. The meeting adjourned at 9:35 a.m.
