### **MINUTES OF THE REGULAR MONTHLY MEETING ON JANUARY 6, 2025**

The Mahoning Township Supervisors held their annual reorganizational meeting on Monday, January 6, 2025 at approximately 9:15 a.m. in the meeting room of the Mahoning Township building located at 4538 West State Street, Edinburg, PA 16116.

**ROLL CALL** was taken by Jean Greco, Secretary/Treasurer. Members present were: Gary Pezzuolo, and Vito Yeropoli. Mark Sackin was absent due to the weather he was out with the road crew. Also, present was Engineer Gregg DelPrincipe, Attorney Kyle McCree, and Chief Robert Sipe.

Newly appointed Chairman Pezzuolo asked for any guest speakers. There were none.

Pezzuolo made a motion to **ADOPT THE MINUTES** of the December 10, 2024 final budget meeting minutes and the motion was seconded by Yeropoli with a vote of all in favor. Yeropoli made a motion to adopt the minutes of the regular meeting minutes for December 10, 202 which was seconded by Pezzuolo with a vote of all in favor.

Pezzuolo made a motion to **PAY THE BILLS** as prepared by Greco since the last month's meeting. The motion was seconded by Yeropoli with a vote of all in favor.

Pezzuolo made a motion to **PAY THE PAYROLLS** as prepared by Greco since the last month's meeting. The motion was seconded by Yeropoli with a vote of all in favor.

There were **NO TOWNSHIP REPORTS PLANNING** or **FIRE DEPARTMENT**. **POLICE REPORT** by Chief Sipe was 46 calls for December and 747 for the calendar year 2024. Greco noting 2 solar panels for zoning. Poncho Exposito did mention that Fire Hall in Edinburg had many updates and improvements.

Pezzuolo noted under **UNFINISHED BUSINESS** was the **TEAMSTERS AGREEMENT** for 2025 – 2027. Pezzuolo made a MOTION to adopt the agreement with a second from Yeropoli and a vote of all in favor.

Pezzuolo noted under **NEW BUSINESS** gratitude and recognition of the **JOHNSON CLUB** for donations to the police and fire departments. Greco sent a letter of thank you already.
