MINUTES OF THE REGULAR MONTHLY MEETING ON MARCH 11, 2025

The Mahoning Township Supervisors held their regular monthly meeting on Tuesday, March 11, 2025 at approximately 6:00 p.m. in the meeting room of the Mahoning Township building located at 4538 West State Street, Edinburg, PA 16116. The Meeting was called to order with the Pledge of Allegiance to the US Flag.

ROLL CALL was taken by Jean Greco, Secretary/Treasurer. Members present were: Gary Pezzuolo and Mark Sackin. Vito Yeropoli was absent due to the death of his father in law. Also, present was Engineer Gregg DelPrincipe and Solicitor Louis Perrotta, Esq.

Chairman Pezzuolo asked for any guest speakers. There was none.

Pezzuolo made a motion to **ADOPT THE MINUTES** of the February 11, 2025 meeting which was seconded by Sackin with a vote of all in favor.

Sackin made a motion to **PAY THE BILLS** as prepared by Greco since the last month's meeting which was seconded by Sackin with a vote of all in favor.

Pezzuolo made a motion to **PAY THE PAYROLLS** as prepared by Greco since the last month's meeting. The motion was seconded by Sackin with a vote of all in favor.

Greco gave the **ZONING REPORT** of 1 garage. Sackin gave the **PLANNING** report noting the approval of 2 subdivisions. Pezzuolo made a **MOTION** to approval the **AYLES SUBDIVISION** which was seconded by Sackin and the vote was all in favor. Sacking made a **MOTION** to approve the **HUNCIK SUBDIVISION** which was seconded by Pezzuolo with a vote of all in favor. No **FIRE DEPARTMENT** report was given. No **POLICE REPORT** was given.

Pezzuolo asked Greco for **ANNOUNCEMENTS** in which she deferred to Sackin for the **ANNUAL SPRING CLEAN UP** set for April 21 – May 3, 2025 Monday thru Saturday. And, noted the **LAWRENCE COUNTY TAX OUTREACH** would be at the Township's lobby on April 28, 2025.

Pezzuolo noted nothing was needed for **UNFINISHED BUSINESS**.

Pezzuolo moved onto **NEW BUSINESS** in which Solicitor Perrotta noted the new state rate for new incoming township supervisors to increase from the long time monthly amount of \$157.25. An **ORDINANCE** would be needed and advertised first for this change to be voted on at the April meeting.

Pezzuolo opened the meeting back up to the public. Greco noted to remind residents on the PA Property Tax Rebate program which qualifies them for the Mohawk Tax Rebate as well.

Pezzuolo noted the initial talks of 2025 paving which would be more discussed at next month's meeting. Greco and Pezzuolo noted increased cost of winter road materials thus far at \$45K vs. \$14K in 2024 for sale and \$7K vs. \$4K for antiskid and that is with GP Construction donating the hauling in 2025.

Resident Virginia Phillips noted that Evergreen Road remains in need do paving.

Pezzuolo noted the **NEXT REGULAR MEETING** will be April 8, 2025 at 6:00 p.m.

Pezzuolo made a motion to **ADJOURN** which was seconded by Sackin with a vote of all in favor. The meeting adjourned at 6:18 p.m.
