MINUTES OF THE REGULAR MONTHLY MEETING ON MAY 14, 2024

The Mahoning Township Supervisors held their regularly scheduled meeting on Tuesday, May 14, 2024 at approximately 6:00 p.m. in the meeting room of the Mahoning Township building located at 4538 West State Street, Edinburg, PA 16116.

ROLL CALL was taken by Jean Greco, Secretary/Treasurer. Members present were: Mark Sackin, Gary Pezzuolo, and Vito Yeropoli. Also present were Engineer Gregg DelPrincipe, and Solicitor Louis Perrotta.

Chairman Pezzuolo asked for any guest speakers. There were none.

Pezzuolo asked for a motion to **ADOPT THE MINUTES** of the April 9, 2024 which was made by Yeropoli and seconded by Sackini with a vote of all in favor. Pezzuolo made a motion to **PAY THE BILLS** as prepared by Greco since the last month's meeting which was seconded by Sackin with a vote of all in favor. Yeropoli made a motion to **PAY THE PAYROLLS** as prepared by Greco since the last month's meeting which was seconded by Sackin with a vote of all in favor.

Greco gave the report for Township **ZONING** which included a pool, pole building, and 2 fence permits Greco also gave the report for **PLANNING** in which there will be a follow up meeting for Keystone Properties and Butch along with the Perret property. No report was given for the **FIRE DEPARTMENT**. No report was given for the **POLICE DEPARTMENT**.

Pezzuolo asked Greco for any **ANNOUNCEMENTS and CORRESPONDENCES** in which Greco note the pool will open at some point early June

Pezzuolo asked for any **UNFINISHED BUSINESS** in which there was none.
