MINUTES OF THE REGULAR MONTHLY MEETING ON JULY 8, 2025

The Mahoning Township Supervisors held their regular monthly meeting on Tuesday, July 8, 2025 at approximately 6:00 p.m. in the meeting room of the Mahoning Township building located at 4538 West State Street, Edinburg, PA 16116. The Meeting was called to order with the Pledge of Allegiance to the US Flag.

ROLL CALL was taken by Jean Greco, Secretary/Treasurer. Members present: Gary Pezzuolo and Mark Sackin. Vito Yeropoli was absent due to having had a liver transplant. Also, present: Engineer Gregg DelPrincipe, Solicitor's Representative Kyle McCree, Esq., and Officer Alfred DeCarbo.

Pezzuolo asked for guest speakers or anyone with comments, complaints – Resident Darren Vzyak spoke of concern of the area along Route 224 near Carbon Micco becoming a nuisance with the noise from gun fire and recent incident of several arrests on Michael Drive. Pezzuolo agreed noting he hears at his house nightly. Mcree noted he would check into ordinance. Vzyak noted being open to helping and meeting with police officers. He mentioned multiple times nothing but respect for officers and supervisors. Fire Chief Exposito noted taking folks out on backboards and the dangers to emergency personnel. Resident Joseph Sallman noted that control needs to get back into place. Many have been riding there since childhood as Pezzuolo agreed; and, those folks are not the problem. Resident Roberta Penwell questioned making it a private riding park. McCree noted he would send letter to owners; and Pezzuolo asked for a plan to be put together with the owners. Greco stepped off the riser and asked to be heard as a resident; not in her role of township secretary/treasurer. Greco noted strong fears in her neighborhood after watching officers from 6 departments be in direct danger of gunfire including Sargent Magliocca. She then stated the caliber and volume of guns, drugs, and cash confiscated from those arrested. She remains quite alarmed with the situation.

Pezzuolo made a motion to **ADOPT THE MINUTES** of the June 10, 2025 meeting which was seconded by Sackin with a vote of all in favor. Pezzuolo asked and Sackin made a motion to **PAY THE BILLS** as prepared by Greco since the last month's meeting which was seconded by Pezzuolo with a vote of all in favor. Pezzuolo made a motion to **PAY THE PAYROLLS** as prepared by Greco since the last month's meeting which was seconded by Pezzuolo with a vote of all in favor.

Greco gave the **BUILDING PERMIT/ZONING REPORT** of 2 new houses, and 2 solar panels. Sackin gave the **PLANNING** which was an approval of a **LOT CONSOLIDATION for DOAN** which Pezzuolo made a **MOTION** which was seconded by Sackin and a vote of all in favor. Sackin also noted a **SUBDIVISION for AMBROSIA** which was **MOTION** by Pezzuolo and seconded by Sackin. **FIRE DEPARTMENT** report was given by Poncho Exposito. He noted the month month of June had 25 calls, 140 hours, and 630 miles. Officer DeCarbo gave a **POLICE REPORT** with 72 calls for the month of June.

Pezzuolo asked Greco for **ANNOUNCEMENTS** in which she noted Attorney McCree joining Attorney Perrotta as a partner.

Pezzuolo began **UNFINISHED BUSINESS** in which DelPrincipe noted a County CDBG Grant application due August 1, 2025. He also noted census and income needed from residents. Suggestions were made for Clay Street and Carbon Micco.

Pezzuolo opened the meeting back up to the public and no one commented.

Pezzuolo noted the **NEXT REGULAR MEETING** will be August 12, 2025 at 6:00 p.m.

Pezzuolo asked for a motion to **ADJOURN** which was made by Sackin and seconded by Pezzuolo with a vote of all in favor. The meeting adjourned at 6:52 p.m.
