The Mahoning Township Supervisors held their regular monthly meeting on Tuesday, September 9, 2025 at approximately 6:00 p.m. in the meeting room of the Mahoning Township building located at 4538 West State Street, Edinburg, PA 16116. The Meeting was called to order with the Pledge of Allegiance to the US Flag.
