### MINUTES OF THE DECEMBER 12, 2023 MONTHLY SUPERVISORS' MEETING

The Mahoning Township Supervisors held their regularly scheduled meeting on Tuesday, December 12, 2023 at 5:55 p.m. immediately following the 2024 Final Budget Meeting which was held at the Mahoning Township Building. Chairman, Vito Yeropoli called the meeting to order indicating the pledge to the US Flag was done previously.

**ROLL CALL** was taken by Jean Greco, Secretary. Members present were Mark Sackin, Gary Pezzuolo, and Vito Yeropoli. Also present was Solicitor Perrotta and Engineer Gregg DelPrincipe.

Yeropoli asked for any guest speakers and/or guests to share their concerns.

Yeropoli asked for a motion to **APPROVE THE MINUTES OF THE NOVEMBER 14, 2023 PRELIMINARY BUDGET MEETING** which was made by Yeropoli and seconded by Sackin with a vote of all in favor. Yeropoli next made a motion to **APPROVE THE MINUTES OF THE NOVEMBER 14, 2023 REGULAR MEETING** which was and seconded by Pezzuolo with a vote of all in favor.

Yeropoli made a motion to **PAY THE BILLS** as prepared by Greco since the last month's meeting. The motion was seconded by Sackin with a vote of all in favor. Yeropoli made a motion to **PAY THE PAYROLLS** as prepared by Greco since the last month's meeting and the motion was made by Pezzuolo with a vote of all in favor.

**TOWNSHIP REPORTS** were given as follows: **ZONING** by Greco – 1 building permits to report. No **PLANNING** was reported. The **FIRE DEPARTMENT** report was given by Poncho Exposito for October and November consisting of 320 YTD man hours, 1180 miles driven, and 50 calls. Officer Hedland shared the **POLICE DEPARTMENT** report with 86 incidents for the month of November 2023.

Yeropoli asked for discussion for any **UNFINISHED BUSINESS** in which there was none.

Yeropoli made a **MOTION TO ACCEPT THE 2024 BUDGET** with no tax increase for the general fund and increased for both the light and hydrant fund the motion was seconded by Sackin with a vote of all in favor.

Yeropoli then set the schedule for the **UPCOMING MEETINGS** for Tuesday, January 2, 2024 at 9:00 a.m. for the 2024 Annual Meeting and then the next regular meeting immediately following.

The Annual Auditors' meeting would be the day following and time set by the auditors. Yeropoli noted he would not be accepting the Chairman position again.

Yeropoli asked for any **OTHER DISCUSSION** which there was none.

There being nothing further Yeropoli made a motion to **ADJOURN** which was seconded by Pezzuolo with a vote of all in favor at 6:02 p.m.
